# Agreement between User and Emergence Health

Welcome to Emergence Health NP Adult Health PLLC ("Emergence Health"). This agreement pertains to the company website, emergence.health ("the Site"), as well as the holistic health care services (the "Services") provided by Emergence Health.

These Services include telehealth and, upon request, home care services in which the provider assesses, diagnoses, treats, and monitors health issues. For some, the focus is on wellness through health care prevention services.

The Services are offered to you conditioned on your acceptance, without modification, of the terms, conditions, and notices contained herein (the "Terms"). Your use of Emergence Health Site and services constitutes your agreement to all such Terms. Please read these Terms carefully, and keep a copy of them for your reference.

## No Medical Care or Advice on the Site

The Site offers an online communication platform for Emergence Health providers and their patients to connect via the Site through the use of synchronous and asynchronous telecommunication technologies. No medical or psychological advice or care is provided on the Site, and only Emergence Health providers deliver clinical care.

The content of the Site and the Services, including without limitation, text, copy, audio, video, photographs, illustrations, graphics, and other visuals, is for informational purposes only and does not constitute professional medical or psychological advice, diagnosis, treatment, or recommendations of any kind. You may always seek the advice of your Emergence Health provider or other qualified healthcare professionals with any questions or concerns you may have regarding your individual needs and any medical conditions.

## Risks of Telehealth Services

By using the Site, you acknowledge the potential risks associated with telehealth services. These include, but are not limited to, the following: information transmitted may not be sufficient (e.g. poor resolution of images) to allow for appropriate medical care decision making by the provider; delays in evaluation or treatment could occur due to failures of electronic equipment; a lack of access to your medical records may result in adverse drug interactions or allergic reactions or other judgment errors; although the electronic systems we use incorporate network and software security protocols to protect the privacy and security of health information, those protocols could fail causing a breach of privacy of your health information.

# Eligibility to Use the Services

By requesting to use, registering to use, and/or using the Services, you represent and warrant that you have the right, authority, and capacity to enter into these Terms and you commit to abide by all of the terms and conditions hereof. You also represent and warrant that you meet the following eligibility criteria:

 The Services are available only to individuals who are eighteen (18) years of age or older. • You must not be a competitor intending to use the Services for reasons that are in competition with Emergence Health.

#### Access to the Services

You may access and use the Site via remote access connectivity. In order to use the Services, you will be asked to register an account and create login information, including, without limitation, username and passwords. Upon registration, you will need to provide us with an email address. We will use email to send you important updates about the Site and Services as well as notifications when information and documents are added that you need to be aware of to use the Services. You consent to receive electronic communications and you agree that all agreements, notices, disclosures, and other communications that we provide to you electronically, via email and on the Site, satisfy any legal requirement that such communications be in writing. In some instances, but not all, you will be able to opt out of receiving emails. You must safeguard your login information that you use to access the Services and you must not disclose this information to anyone. You must immediately notify Emergence Health of any unauthorized use of your user account or of any other breach of security that you become aware of involving and relating to the Services by email to info@emergence.health.

# Online Payments

You can purchase Services on the Site. We accept credit and U.S. debit cards. If a credit card account is being used for a transaction, Emergence Health may obtain pre-approval for an amount up to the amount of the payment. If you enroll to make recurring payments automatically, all charges and fees will be billed to the credit card you designate during the setup process. If you want to designate a different credit card or if there is a change in your credit card, you must change your information online. This may temporarily delay your ability to make online payments while we verify your new payment information.

You represent and warrant that if you are making online payments that: (a) any credit card, debit card and bank account information you supply is true, correct, and complete; (b) charges incurred by you will be honored by your credit/debit card company or bank; (c) you will pay the charges incurred by you in the amounts posted, including, without limitation, any applicable taxes; and (d) you are the person in whose name the card was issued and you are authorized to make a purchase or other transaction with the relevant credit card and credit card information.

### **User Information**

If you submit, upload, post or transmit any health information, medical history, conditions, problems, symptoms, personal information, consent forms, agreements, requests, comments, ideas, suggestions, information, files, videos, images or other materials to us or our Site ("User Information"), you agree not to provide any User Information that (1) is false, inaccurate, defamatory, abusive, libelous, unlawful, obscene, threatening, harassing, fraudulent, pornographic, or harmful, or that could encourage criminal or unethical behavior; (2) violates or infringes the privacy, copyright, trademark, trade dress, trade secrets or intellectual property rights of any person or entity; or (3) contains or transmits a virus or any other harmful component. # Cancellation/Refund Policy

Emergence Health offers patients a choice between two membership plans. Each membership plan is for a term of twelve months. You have 30 days from purchasing your membership plan to change your mind. If you have not used any of your membership plan, you will be issued a full refund minus the \$125 non-refundable registration fee. If you have used components of your membership plan/benefits, you will receive a full refund minus fees associated with any Services used according to the following: \$150 per 15 minutes (ex. 30 min visit=\$300). After 6 months, you may cancel at any time for a \$500 cancellation fee.

The membership plan will automatically renew for successive 12-month terms. If you do not wish to renew your membership plan, you must provide Emergence Health with written notice of your intent not to renew no less than 30 days prior to the expiration of the then-current term. You will not be charged a processing fee if you elect not to renew, provided you have completed the annual membership and are a current member. Membership benefits are in effect for 12 months upon purchasing a membership plan. If benefits are not used within the 12 month period of service, they are not carried over into the next year.

The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms.
